**IMPORTANT:** This form must be filled out and signed by each participant or by the parent or legal guardian of each child under 18 years of age who wishes to participate in the activities. **This is a legal document, release of liability. Please read and understand before signing.**

**ACKNOWLEDGEMENT OF RISK, WAIVER, RELEASE AND  
INDEMNIFICATION**

I have asked to participate in Torrance County Archaeological Society activities and events. I understand that participation in these activities is not without risk. Certain risks cannot be eliminated due to the activity's setting. The same elements that contribute to the character of these activities can be cause of loss or damage to my property, accidental injury or illness or, in extreme cases permanent trauma or death.

I agree to assume full responsibility for myself and that of my family, including minor children. I expressly assume all risk and responsibility involving accidents sustained while participating in activity programs of Torrance County Archaeological Society resulting from negligence on my part, that of my family or officers, directors, agents or members of Torrance County Archaeological Society or the landowners of the premises.

I affirm that I am fully capable of participating in this activity and that my general health is good, that I do not have any condition that might endanger the life or health of myself or others participating in any activity. I affirm that I know of no reason why I should not participate.

I understand the signature of the parent or guardian of a minor child on this document shall make all provisions of this release and assumption of the risk agreement applicable to and binding on the minor child. I agree that New Mexico law shall govern this release.

I, on behalf of myself, my children, my assigns and my estate, agree to release and hold harmless Torrance County Archaeological Society, its officers, board of directors, agents or members and landowners of the premises for any and all claims for injuries, causes of action, or liability related to participation in any activity of the Torrance County Archaeological Society. Should Torrance County Archaeological Society or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold Torrance County Archaeological Society and the landowner of any premises harmless for all such fees and costs.

By signing this document, I acknowledge that if anyone is hurt or property damaged during my or my child's participation in these activities, I and/or my child may be found by a court of law to have waived any right to maintain a lawsuit against Torrance County Archaeological Society and the landowner of the premises on the basis of any claim

which has been released herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and agree to be bound by its terms.

This liability release shall be legally binding upon heirs, my assigns, legal guardians, personal representatives and myself. I have carefully read this agreement and understood its contents. I am aware that I am releasing certain rights that I otherwise may have, and I enter into this agreement on behalf of myself, minor children, and/or wards, of my own free will.
